

**VILLAGE OF CAMPTON HILLS
ZONING ORDINANCE AMENDMENT
(Police Stations and Fire Stations as Special Uses)**

WHEREAS, a certain proposed amendment to the Zoning Ordinance of the Village of Campton Hills was referred by the Corporate Authorities to the Plan Commission; and

WHEREAS, the Plan Commission held a public hearing after proper notice and publication as required by law; and

WHEREAS, the Plan Commission has made its recommendations to the Corporate Authorities as set forth below.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois that:

Section 1. The Zoning Ordinance of the Village of Campton Hills is hereby amended as follows:

- A. Section 8.1-2 is amended to add a new subsection s.1 "Police Stations and Fire Stations"
- B. A new Section 8.2-6 "Special Uses" is hereby added and subsection a. is added thereto as follows: "Police Stations and Fire Stations."
- C. Section 8.3-2 is hereby amended to add subsection h.2 "Police Stations and Fire Stations"
- D. Section 9.1-1 is hereby amended to delete subsection d "Police Stations and Fire Stations."
- E. Section 9.1-2 is hereby amended to add subsection d "Police Stations and Fire Stations".
- F. Section 9.5-1 is hereby amended to delete subsection j "Police Stations and Fire Stations".
- G. Section 9.5-2 is hereby amended to add subsection g.1 "Police Stations and Fire Stations".
- H. Section 10.1-3 is hereby amended to add subsection a "Police Stations and Fire Stations".

- I. Section 10.2-2 is hereby amended to add subsection e.1 "Police Stations and Fire Stations".
- J. Section 10.3-1a is hereby amended to delete the words "except subsections a and j thereof" and to replace the same with "except subsection a thereof".
- K. Section 10.3-2 is hereby amended to add subsection c "Police Stations and Fire Stations".
- L. Section 10.4-1a is hereby amended to delete the words "except subsections a and j thereof" and replace the same with "except subsection a thereof".
- M. Section 10.4-2 is hereby amended to add subsection i.1 "Police Stations and Fire Stations".
- N. Section 10.5-1a is hereby amended to delete the words "except subsections a and j thereof" and replace the same with "except subsection a thereof".
- O. Section 10.5-2 is hereby amended to add subsection b "Police Stations and Fire Stations".
- P. Section 10.6-1 is hereby amended to delete the words "except subsections a and j thereof" and replace the same with "except subsection a thereof".
- Q. Section 10.6-2 is hereby amended to add subsection a "Police Stations and Fire Stations".
- R. Section 10.7-1 is hereby amended to delete the words "except subsections a and j thereof" and replace the same with "except subsection a thereof".
- S. Section 10.7-2 is hereby amended to add subsection a "Police Stations and Fire Stations".

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law. This ordinance shall be published in pamphlet form.
