

**ORDINANCE AMENDING OFFICIAL COMPREHENSIVE PLAN
OF THE VILLAGE OF CAMPTON HILLS,
KANE COUNTY, ILLINOIS**

WHEREAS, pursuant to Sections 11-12-5 et seq. of the Illinois Municipal Code (65 ILCS 5/11-12-5 et seq.) the Village of Campton Hills adopted Ordinance No. O-07-31, adopting an Official Comprehensive Plan and an Official Map affecting all property within the Village of Campton Hills, Kane County, Illinois and the unincorporated territory within one and one-half (1 ½) miles of the Village boundary; and

WHEREAS, there has been presented to the Village by the Joint Environmental Resource Management Committee, assisted by Rob Linke of Trotter and Associates, Inc. and by Jack Shouba, Open Space Coordinator for Campton Township, a document entitled "Green Infrastructure in the Village of Campton Hills, August 2010 (the Green Infrastructure Report)"; and

WHEREAS, the Corporate Authorities of the Village of Campton Hills referred said Green Infrastructure Report to the Plan Commission of the Village for review and for recommendation as to possible inclusion of said Green Infrastructure Report into the Official Comprehensive Plan of the Village; and

WHEREAS, the Plan Commission has held a public hearing, pursuant to notice as required by law, on the question of amending the Official Comprehensive Plan of the Village to include said Green Infrastructure Report within and as part of said Official Comprehensive Plan; and

WHEREAS, the Plan Commission of the Village has recommended to the Corporate Authorities the amendment of the Official Comprehensive Plan, as provided below in this Ordinance, to include said Green Infrastructure Report:

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois that:

SECTION 1. The Official Comprehensive Plan of the Village of Campton Hills, Kane County, Illinois is hereby amended as follows:

1. There is hereby added to Section IV (entitled "Objectives and Goals") of said Official Comprehensive Plan, at the end of said Section IV, a new subsection entitled "Green Infrastructure in the Village of Campton Hills, August 2010" as set forth in Exhibit A to this Ordinance.

SECTION 2. The Village Clerk of the Village of Campton Hills, Kane County, Illinois shall file notice of the adoption of this Ordinance amending the Official Comprehensive Plan of this Village with the Recorder of Kane County.

SECTION 3. This Ordinance shall be full force and effect upon its passage and approval and upon the expiration of ten (10) days after the date of filing notice of the adoption of this ordinance with the Recorder of Kane County.
