

**VILLAGE OF CAMPTON HILLS
 APPROPRIATION ORDINANCE
 MAY 1, 2011 THROUGH APRIL 30, 2012**

WHEREAS, it is necessary and appropriate that the Village adopt an Appropriation Ordinance authorizing expenditures for the period May 1, 2011 through April 30, 2012.

WHEREAS, the proposed Appropriation Ordinance was available for public examination for not less than ten (10) days prior to adoption; and

WHEREAS, a public hearing on the proposed Ordinance has been held with Notice of said hearing having been published at least ten (10) days prior thereto, pursuant to law;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, that:

SECTION 1: The following sums or so much thereof as may be authorized by law, be and the same are hereby appropriated from monies received and to be received by the Village of Campton Hills from all sources for the corporate purposes of the Village of Campton Hills, Kane County, Illinois to defray all necessary expenses and liabilities of said Village of Campton Hills, as hereinafter specified for the fiscal year commencing on May 1, 2011 and ending on April 30, 2012:
