

VILLAGE OF CAMPTON HILLS  
EMERGENCY APPROPRIATION ORDINANCE

WHEREAS, the Village of Campton Hills was incorporated on May 14, 2007; and

WHEREAS, as a newly incorporated municipality, the Village of Campton Hills has had no prior Appropriation Ordinance and thus does not come within the statutory rule allowing a municipality to continue spending in the first quarter of its fiscal year prior to adoption of a new Appropriation Ordinance at the same level as in the prior year's Appropriation Ordinance; and

WHEREAS, there are certain expenditures which the Village will be required to undertake prior to adoption of its annual Appropriation Ordinance pursuant to and after a public hearing and notice as otherwise provided by law; and

WHEREAS, accordingly, it is necessary and appropriate that the Village adopt an Emergency Appropriation Ordinance authorizing expenditures until the annual Appropriation Ordinance is adopted prior to July 31, 2007:

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, that:

**SECTION 1:** The following sums or so much thereof as may be authorized by law, be and the same are hereby appropriated for the corporate purposes of the Village of Campton Hills, Kane County, Illinois, to defray all necessary expenses and liabilities of said Village of Campton Hills, as hereinafter specified for the fiscal year commencing on the 14<sup>th</sup> day of May, 2007 and ending on the 30th day of April, 2008, subject to any subsequent amendment of this Appropriation Ordinance prior to July 31, 2007, to wit:


**SECTION 2:** The said several sums of money are hereby appropriated from moneys received and to be received by the Village of Campton Hills from all sources.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage and approval as required by law. This Ordinance shall be published in pamphlet form.


