

**VILLAGE OF CAMPTON HILLS  
AN ORDINANCE CORRECTING SECTION NUMBERS IN  
ORDINANCE NO. O-07-06, AN AMENDMENT TO TITLE 2 (BOARDS  
AND COMMISSIONERS) TO ADD CHAPTER 3, BOARD OF FIRE AND  
POLICE COMMISSIONERS**

WHEREAS, there was a scrivener's error in referring to Section numbers Ordinance No. O-07-06 in that the references to Sections 2-1-1 and 2-1-2 should have been to Section 2-3-1 and 2-3-2, respectively:

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, as follows:

**Section 1.** Ordinance O-07-06 is hereby amended and restated to provide follows:

"Chapter 3 Board of Fire and Police Commissioners

"Section 2-3-1. **Established; membership; terms.**

There shall be a Board of Fire and Police Commissioners, as provided by law which shall consist of three (3) members whose terms shall be staggered and three (3) years. Such members shall be appointed by the President with the advice and consent of the Board of Trustees.

"Section 2-3-2. **Duties.**

The Board of Fire and Police Commissioners shall have charge of appointments of full-time members of the Police Department, excepting that the Chief of Police who shall be appointed by the Village President with the advice and consent of the Board of Trustees, and said Board shall conduct and hold all entrance and promotional examinations in the manner required by rules and regulations as they may be established from time to time and required by law. The Board of Fire and Police Commissioners may utilize intergovernmental cooperative as its agent for the purpose of administering such examinations if authorized to do so by the President and Board of Trustees."

**Section 2.** This Ordinance shall be in full force and effect from and after the date of its passage and approval as required by law. This Ordinance shall be published in pamphlet form.
