

**VILLAGE OF CAMPTON HILLS
RESOLUTION APPROVING AND AUTHORIZING
EXECUTION THEREOF AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE
VILLAGE OF CAMPTON HILLS AND CAMPTON TOWNSHIP HIGHWAY DISTRICT
REGARDING CERTAIN STREETS IN PLATO TOWNSHIP**

WHEREAS, upon the incorporation of Village of Campton Hills, the Village assumed jurisdiction over those township roads which lie within the boundaries of the Village including certain roads in Plato Township; and

WHEREAS, the Village and the Campton Township Highway District have negotiated an Intergovernmental Agreement providing for the future maintenance by the Campton Township Highway District of the former Plato Township roads which are now the responsibility of the Village, excepting, however, snow plowing and ice control on the roads within Briarwood, Tall Pine and Woodbridge Subdivisions; and

WHEREAS, it is in the best interest of the Village of Campton Hills and its citizens that the Intergovernmental Agreement which attached hereto as Exhibit A and a part hereof be approved in substantially the form presented and executed in substantially the form attached:

NOW THEREFORE, BE IT RESOLVED By the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois that:

Section 1. The Corporate Authorities find that the statements in the preamble to this Resolution are correct.

Section 2. The Intergovernmental Agreement which is attached to this Resolution as Exhibit A is hereby approved in substantially the form so attached and the President and Village Clerk are authorized to execute said document, subject to such non-substantive changes as may be approved by the Village Attorney and Village President.

Section 3. This Resolution shall be in full force and effect from and after its passage and approval pursuant to law.
