Message to the Residents

In April 2007, residents voted to incorporate the Village of Campton Hills and then on February 5th, the residents of Campton Hills participated in its first election selecting their Village board. In both cases, residents turned out in large numbers to make their voices heard about their local community. As a result, those who supported a pro-Village point of view won 7 of 8 offices.

Where Does The Village Get Its Money?

The Village Board has heard from residents who want to know how the Village receives money to operate the Village since there is no municipal property tax. It is important that residents understand that we can manage our Village without a municipal property tax because the state of Illinois provides all municipalities with substantial revenue to help them. In an effort to provide the answer to this question, we have provided the data below.

* Illinois Municipal League estimates the 2009 Fiscal Year (5-1-08 through 4-30-09) contribution at \$134.35. The certified population based upon the 2000 US Census was 10,504. This number will be adjusted upon completion of the Special Census.

Special Census

Many of the Village residents will have U.S. Census takers show up on their doorsteps to count the number of residents living in their homes this spring. This census will only cover a portion of Campton Hills, so not every home will be counted. The Census takers will have credentials available for viewing. In the near future, the US Census Bureau will begin the interview and testing process and once started, the Census is expected to take approximately 6 weeks.

Village Permits and User Fees

The Village has contracted with Kane County to provide building permit and inspection services. One of the conditions of this agreement was that the Village was required to hire a Zoning Officer to review all plans submitted for compliance to the Village zoning ordinance. If you are planning on building or adding an improvement or addition to your home or business, please contact Chris Ranieri at Village Hall to verify whether you are required to have your application approved by the Village before submission to the County. The zoning review fees range from \$20 for a privacy fence permit up to \$500 for a new commercial business.

NO PROPERTY TAX INCREASES WITHOUT VOTER APPROVAL

Your village is committed to keeping taxes low. In fact, the Village of Campton Hills cannot impose property taxes on the voters without referendum approval. This fact was confirmed in an article by the Kane County Chronicle on October 28th (“State Taxes need voter OK).

Specifically, “According to the Illinois Department of Revenue, Campton Hills is under the Property Tax Extension Limitation Law, or tax cap, and cannot levy any property tax for any purpose without voter approval by referendum.” Village officials have always been and remain in favor of running our village government with existing tax revenues that are returned to the municipality from the state and county.

TAX CAP LAW

The Property Tax Extension Limitation Law (a.k.a. PTELL or Tax Cap Law) requires “new municipalities which have not extended a tax levy (Campton Hills has a zero levy) to hold a referendum establishing a maximum aggregate extension for the levy year.” See Illinois State Statute 35 ILCS 200/18-210. This rule requiring voter approval via referendum for new taxes applies to those property taxes that are normally exempt from referendum because Kane County adopted the Tax Cap provision, and thus “increases in these otherwise non-referendum taxes are subject to the Tax Cap” (Illinois Municipal Handbook, p. 1999).

COMPREHENSIVE PLAN

The Village of Campton Hills unanimously passed an ordinance to implement a “Comprehensive Plan” which serves as a guide for the future development of the Village. One of the reasons we became incorporated was to allow every resident a direct voice in issues affecting this community, neighborhoods, property values and schools.

The Comprehensive Plan will set forth guidelines for development and is very similar to plans adopted by Kane County and Campton Township. To view a draft of the Official Comprehensive plan, please visit www.villageofcamptonhills.org to download the PDF file.

Police Department Update

Email Alert and Notification System

The Campton Hills Police Department has started an email alert and notification system to publish information in a timely manner. Examples of information that may be included would be, crime patterns in neighborhoods, alerts for missing children, help in locating offenders in crimes, crime prevention tips, and dealing with other issues and rumors as they apply to the CHPD. To join this email system, send the Chief an email at chief@villageofcamptonhills.org and you will be included on the email system.

Vacation Checks

The CHPD provides for vacation checks when residents are out of town. You may either visit the police department area of the Village website at www.villageofcamptonhills.org and submit a vacation check request, or contact the CHPD at 630-584-0330. The CHPD will attempt to frequently check your home while you are away.

Traffic Enforcement

Many residents have asked for increased traffic enforcement and have provided specific locations where they would like increased enforcement. If you are aware of a location that you believe is hazardous, please call the CHPD and advise us of the location. The CHPD will make an assessment of each location brought to our attention.

Many people are unaware of what to do if stopped by a police officer, either in Campton Hills or elsewhere. If stopped by a police officer, keep your hands in plain sight such as on the steering wheel. Police officers are most frequently hurt on traffic stops and their awareness is heightened for safety. The police officer may ask for your driver's license and proof of insurance before even advising you of what you were stopped for. If the officer decides to issue a citation, they may take a bond for the traffic ticket. The bond is set by the State of Illinois and the courts and is taken only to insure that the driver will not ignore the traffic ticket. Acceptable bonds that may be taken by a police officer are: driver's licenses, insurance bond cards (e.g. AAA cards), cash, or credit cards. Many tickets can be taken care of by mail or even on the Internet. Court supervision may allow you to keep the traffic ticket off your driving record and hidden from your insurance company. When you are stopped, you should be given an envelope and slip that describes these options, if they are available for your violation.

Village Road Report

It is that time of year when potholes appear overnight. This winter has been especially hard on our roads and potholes are the result. The Campton Township Highway District will be cold-patching the Village Roads as soon as conditions allow. Before a patch is applied, the hole must not have any salt in it and the hole must be dry. This spring, we will also be making repairs to the right-of-ways where snowplows may have damaged the grass.

Because of the severe winter we are not able to finalize the roads that will be resurfaced this summer. A re-evaluation of the roads will have to be made as the weather warms. One road that will definitely be resurfaced this summer will be Bolcum Road east of the Prairie Lakes subdivision, During the summer of 2009, Anderson between Route 38 and Route 64 will be resurfaced thanks to a matching grant we were able to get from the Illinois Department of Transportation.

Election Results & Referendum Review

On February 5th, the Village of Campton Hills placed three advisory referendums on the ballot in order to give residents a voice in decisions that impact their community. One of the top reasons residents support incorporation is so they can control their own destiny and have a local voice on local matters. 59.52% of voters in Campton Hills showed up to vote!

PASSED: Park Impact Fees for Developers

Residents of Campton Hills supported a referendum that would charge developers impact fees to fund the acquisition of local parks. As a result, the Village will now pursue Phase Two of the Land/Cash ordinance enacting the wishes of the residents. Once passed, developers will have to either donate land or pay an impact fee for parks to the Village based upon the number of residents generated from new development. According to the Kane County Clerk's office, 55% of Campton Hills' residents supported this referendum.

FAILED: Mosquito Abatement; Early Warning Sirens

Residents of Campton Hills rejected two separate non binding advisory referendums; one was related to controlling the mosquito population and the other asked about the installation of emergency sirens. The Campton Township Highway District provides a minimal amount of mosquito control within the Village right-of-ways for roads located within Campton Township. The Village will not be pursuing any additional mosquito abatement or the installation of early warning sirens.
